RE: Update on the progress of Mophane International Cargo Airport

This is to acknowledge receipt of your letter dated 6th February 2025 on the above subject matter.

Again, I thank you for your informative visit and appreciate your interest in partnering with BITRI. The benefits are clear since we do receive a reasonable amount of goods from outside the country.

As we indicated in our meeting, BITRI was established in 2012 and the aim was to conduct needs-based technology research that provides sustainable innovative solutions through co-creation and collaboration.

In 2021, the government gave BITRI another responsibility, to form National Electric Mobility (eMobility) Programme. The eMobility is echoed around Vision 2036, with a specific focus on 'Accelerating inclusive economic growth through innovation in a sustainable e-Mobility ecosystem'. The eMobility ecosystem will be characterized by various actors participating in the value chain with various economic activities. The focus in Botswana as we start the programme is on boats, utility vehicles, passenger cars. In addition, BITRI was also mandated to form a special purpose vehicle (SPV) under BITRI to lead the operations of eMobility. The SPV has since been duly incorporated under the name eMobility Botswana Pty Ltd.

I wish to confirm our interest in partnering with 123 Dimension Pty Ltd on the Cargo Airport project pending approval from our parent ministry.
